# Articles of Incorporation of "Chattahoochee Cove Homeowners Association, Inc."

#### Article I

The name of this corporation shall be "Chattahoochee Cove Homeowners Association, Inc."

## Article II

The corporation shall have perpetual duration.

#### Article III

This corporation shall have no stock or stockholders; it is not organized and shall not operate for profit or pecuniary gain; and no part of the net earnings of this corporation shall inure to the benefit of any member, director, officer or any private individual except that reasonable compensation may be paid for services rendered to or for this corporation affecting one or more of its purposes. No part of the activities of this corporation shall be for carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of any candidate for public office.

#### Article IV

This corporation is organized for the purpose of owning, maintaining and administering the Common Area of Chattahoochee Cove; administering and enforcing the covenants and restrictions contained in the Declaration of Covenants, Condition and Restrictions (the "Declaration") and collecting and disbursing the assessments and charges created in the Declaration and any amendments thereto.

When used in these Articles of Incorporation, words such as, for example, "Developer", "Townhouse", "Unit", and "Owner", shall have the same meaning as set forth in the Declaration, unless the context shall prohibit.

Insofar as permitted by law, this corporation shall have the power to do anything that in the opinion of the Board of Directors of this corporation will promote, directly or indirectly, the recreation, health, safety, welfare, common benefit and enjoyment of the Owners and occupants of Units in Chattahoochee Cove, including, but not limited to, the power (i) to purchase, accept by gift, lease, hold, sell, mortgage, convey, or otherwise acquire or dispose of any real and personal property necessary or proper for the carrying out of the purposes of the corporation; (ii) to own, acquire, construct, equip, operate, and

maintain amenities, services, and facilities incident to the purposes of the corporation; (iii) to fix, levy and collect assessments as provided in the Declaration; and (iv) in general, to exercise all the rights, powers, privilege and immunities as are provided and allowed in the Declaration and as are provided and allowed for similar corporations under the laws of Georgia, including, but not limited to the Georgia Nonprofit Corporation Code, subject, however, to any limitations set forth in the Declaration.

#### Article V

The membership of this corporation shall be comprised of the Owners of Units in Chattahoochee Cove as set forth in the Declaration. Voting by the members of this corporation shall be as set forth in and subject to the provisions of the Declaration.

#### Article VI

Directors shall be elected and serve as provided in the By-Laws of this corporation. Developer shall have Class B voting membership which shall entitle Developer to three (3) votes per Unit owned during the period set out in the Declaration and the right to create additional units entitled to votes all as set out therein. The number of Directors constituting the initial Board of Directors shall be three (3), and the name and address of each such Director is:
