FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CHATTAHOOCHEE COVE HOMEOWNERS ASSOCIATION

Each Owner shall have an exclusive easement for ingress, egress, maintenance and any other purpose deemed necessary to the Unit Owner and not in violation of any provision hereof over and across the Limited Common Area adjacent to and as an appurtenant to his Unit."

All other terms and conditions of the Declaration shall remain in full force and effect and is hereby re-ratified.
